

Pinty's Ultimate Fan Cave Contest Official Rules and Regulations

The Pinty's Ultimate Fan Cave Contest is intended only for residents of Canada (excluding residents of the province of Quebec) who have reached the age of majority in the province/territory in which they reside at the time of entry. This Contest will be interpreted according to federal and provincial law. Pinty's Delicious Foods Inc. (hereafter referred to as the "Sponsor") will conduct the Contest.

1. Contest Period

The Pinty's Ultimate Fan Cave Contest (hereafter referred to as the "Contest") begins on September 26, 2020 12:00:01 AM ET and concludes November 8, 2020 at 11:59:59 PM ET, the Contest Closing Date (hereafter referred to as the "Contest Closing Date").
